

TERMS AND CONDITIONS WIFI HOTSPOT LAS DALIAS

1) INTRODUCTION: These conditions apply to the Internet access service for clients and visitors of the Las Dalias Market (hereinafter the Service) and constitute a contract between you (hereinafter "you" or "the User") and the entity LA SALA DALIAS S.L. (hereinafter "LAS DALIAS"), with registered office at Ctra. San Carlos, KM. 12, 07850 Santa Eularia des Riu - Ibiza (Illes Balears), C.I.F. B07949324. In addition to our address the Users will be able to direct their petitions, questions or claims to privacy@lasdalias.es.

By clicking on the "continue" button, you expressly declare that you have read and accept without reservation the present conditions of the Service. Therefore, you must read this document before using the Service, as well as each time you access it, as we reserve the right to change, modify, add or remove part of these conditions at any time. If you do not agree with these conditions you should not use this Service.

2) CONDITIONS:

1. Use of the Service is reserved for LAS DALIAS customers and visitors over 18 years of age.

2. Internet access will be made with the User's own electronic devices. LAS DALIAS does not provide any technical or technological assistance to users using the Service.

3. The User assumes exclusive responsibility for the actions carried out through access, especially with regard to the possible commission of criminal or administrative infractions. In the event that non-compliance with these conditions leads to the endangerment, with or without damage, of the LAS DALIAS information system and, in particular, of the personal data contained therein, the corresponding legal responsibilities will be taken.

4. Users commit to use the Service lawfully, in accordance with the provisions of these conditions and in such a way that they do not harm the rights or interests of LAS DALIAS or third parties. By way of illustration and in no limiting or excluding case, the User undertakes to:

- Not engage in illegal activities or contrary to public order or good faith;

- Not to use the Service to send unsolicited communications (spam).
- Not to carry out actions that imply or imply a violation of the intellectual property rights of LAS DALIAS or third parties;

Without prejudice to the rights recognised to consumers by Royal Legislative Decree 1/2007, of 16 November, the use of the Service will be governed by Spanish law to the exclusion of its conflict of law rules and any controversy that may arise therefrom will be subject to the jurisdiction and competence of the Courts and Tribunals of Ibiza, the users expressly
